Financial Review of New Life Christian Fellowship Narrabri Incorporated 01/07/2023 – 30/06/2024

To whom it may concern,

New Life Christian Fellowship Narrabri Incorporated's total revenue for the year is less than \$500,000 and is considered a small charity organisation. As such no financial review is required to be undertaken according to the Australian Charities & Not-for-profits Commission (ACNC). 1

Even though a review is not required, I was asked to conduct an independent review of the financial accounts for the financial period 01/07/2023 to 30/06/2024.

Records checked:

The income and expenditure reviewed appeared to be recorded correctly and substantiated with supporting documentation.

Recommendations:

If/when New Life Christian Fellowship Incorporated has an annual revenue exceeding \$500,000 (or is no longer a 'small' charity according to the current ACNC rules), an independent audit review by a registered Accountant would be recommended to ensure continued compliance is met.

Betty's Place has been established as a place where women can come to talk about pregnancy, especially unplanned or unexpected pregnancy.



They have made some good contacts with some of the health agencies around town, especially the ones who support indigenous women.

There have been a couple of really good experiences over the course of the year.

One young lady was pregnant and asked if








Recently we have made contact with a woman who already has children, one of them with a chronic health condition. The partner demanded that she abort the baby but she refused. She has recently had the baby. We have offered a pram and other baby stuff to her. We hope to make contact soon, but she leads a very complicated life.

At the moment Betty's Place is also serving as a temporary (more or less) accommodation for Anthony and for Matt Cochrane when he is here to do plumbing and other work. That is providing us with ideas about how to help men who are hurting over broken relationships and the inability to connect with their children.

Betty's Place is going to be a wide ranging source of hope to many people in the years to come.





STOREHOUSE REPORT

The Storehouse commenced in January 2023. The idea is to collect money from our members, distributing half of it to external mission groups and saving half of it to invest at higher returns. We hope that over the course of a few decades we will amass a sizeable fund that might be used for some useful goodly purpose.

The Storehouse was originally set up as a separate incorporated association, Narrabri Mission Support Group Inc. However, recent changes to taxation and charities laws meant that we could possibly be denied tax exemption and be liable for company tax on our surpluses. The Storehouse is now included in the New Life accounts.

In the past twelve months, we have been happy to send good donations to Schools Ministry, Shared Table, Tent of Promise and Lifequip.

As of June 30th 2024, the Storehouse had a total of \$22734.19 in the bank, including \$14,906.93 in a Term Deposit. We will be looking at higher return investment funds when that term deposit expires.

A Dream For New Life

I see a church in Narrabri where people in their hundreds come to find water in the desert of their lives. The presence of God refreshes their spirits and the love of God's people brings hope to refresh their hearts.

I see a church in Narrabri that gathers weekly in homes and other places around the town and beyond. I see a church with a hundred cells meeting each day as lighthouses, shining Jesus' love in each street and neighbourhood. Our cell groups will be places of friendship, encouragement, evangelism and growth in our knowledge of God.

I see a church in Narrabri that brings together the diversity of cell groups and shows each person that they belong to something bigger. Each week we will celebrate what God is doing in our community. We will worship together and we will learn together.

I see a church in Narrabri where God's presence is experienced in every meeting, whether a cell group or a Sunday celebration. When we meet we will pursue the power and grace of the Holy Spirit and allow Jesus to transform us. As He changes us, we will find grace to take Him to our friends and neighbours. Encounters with the living God will ripple out across the Shire of Narrabri as we live in God's presence every day.

I see a church in Narrabri where anyone can become all they were created to be. We have been called to restore those who are broken, to walk with those who are lonely, to heal those who are wounded, to accept those who are rejected. We will be a community where every person has a chance to receive the healing grace of Jesus. We will be a community where every believer has the chance to be a pipeline for the healing grace of Jesus. We recognise that a true community finds ways of practical, emotional and spiritual support for its members as they are lifted from brokenness.

I see a church in Narrabri that sends evangelists, pastors, teachers and missionaries. We will equip those who belong to the church to go beyond the church. We will send them out to take God's grace to the region, the nation, the world.

I see a church in Narrabri that makes it easy to belong, to be healed, to believe, and to grow.

By the grace of God, New Life will be that church.
